## National Lottery Heritage Grants

### Cumbria Seed Bank Project

Applicant: Cumbria Wildlife Trust Limited

Project Description: To preserve the genetic heritage and diversity of native plants by ensuring that the grasslands can support various species, providing food and nesting sites for invertebrates, mammals and birds.

Decision: Award of £250,000.00 (67.04%)

### Learning, preserving and improving: revealing Sunderland's natural and built urban heritage - 2024-2025

Applicant: Norfolk Street Arts Community Interest Company

Project Description: To connect communities with the history of Sunderland's townscape through oral history collections and other heritage engagement activities.

Decision: Award of £63,105.00 (96.19%)
