# National Lottery Heritage Grants £10,000 to £250,000

#### **HEART: Heritage, Environment and Resilience Together**

Applicant: The Lake District Foundation

Project description: To deliver short and long-term climate action to protect the Lake District World Heritage Site from climate change-induced risks and damage, involving the local community, landowners and other active groups with shared goals.

Decision: Award grant of £205,564 (100%)

#### **REVERB: Echoes of Barrow in Furness Music Scenes**

Applicant: Octopus Collective Ltd

Project description: To share and celebrate Barrow-in-Furness' grass roots pop music heritage by collecting materials securing participation from key stakeholders and active community members, to attract and inspire new and younger audiences.

Decision: Award grant of £11,000 (96%)

### Writing on the Wall: 25 Years of Creating Change Through the Power of Words

Applicant: Writing on the Wall Limited

Project description: To focus on conserving Writing on the Wall's 25-year archive, deliver a community engagement programme and conduct a feasibility study for the long-term preservation of the collection.

Decision: Award grant of £198,196 (90%)

#### The New Norse Stars

Applicant: Windermere Science Festivals CIC

Project description: To revive interest in Viking Heritage in Furness through learning events and activities with young people in the area.

Decision: Award grant of £30,872 (95%)

### **Dancing Threads**

Applicant: Global Grooves

Project description: To protect and secure the future of traditional dance and textile practices in Morris, South Asian and carnival and procession cultures, with performance and workshops, and supporting the community to become custodians of these practices.

Decision: Award grant of £72,812 (46%)

### **A Century of Memories**

Applicant: Rotherham United Community Trust

Project description: To gather memories of those involved with the club over the past 100 years through creation of memorabilia and activities, aiming to engage and connect a diverse range of community members.

Decision: Award grant of £100,600 (95%)

### The Big K: The Pit That Shaped a Community

Applicant: One to One Development Trust

Project description: To produce a film capturing the stories and voices of those affected by The Big K, the UK's last deep coal mine, and sharing the film through interactive public screenings.

Decision: Award grant of £15,140 (100%)

Applicant: The Gresley Society Trust

Project description: To commemorate the 150th birthday of Sir Nigel Gresley in 2026 by sharing the story of his life, works and legacy through The Gresley Society's and partnering organisations' records and artefacts.

Decision: Award grant of £16,700 (97%)

Project description: To produce an oral history archive of significant but under-shared social heritage of older LGBTQ+ people, people seeking asylum and women who are unpaid carers and parents in Leeds.

# Northumberland Coast Dark Skies: Conserving and connecting the nocturnal heritage of the Northumberland Coast National Landscape

Applicant: Northumberland County Council

Project description: To protect Northumberland Coast's dark skies by improving control of light pollution, protecting and supporting nocturnal species and engage the community to support the area's conservation.

Decision: Award grant of £227,247 (80%)

### North East Disability History: Past, Present and Future

Applicant: Difference

Project description: To celebrate disability history in line with the 30th anniversary of the Disability Discrimination Act by building from previous projects, producing new material from people's stories, and sharing in accessible spaces.

Decision: Award grant of £108,963 (100%)

# **MUTTON: Young People Reclaiming Local Heritage**

Applicant: Brave Words CIC

Project description: To convey parallels in poverty in Leeds in the present and the 1800s through theatre, while involving young people in research and performance, and engaging adults in heritage and storytelling workshops.

Decision: Award grant of £15,249 (29%)

### Standing Firm in Power and Pride: Black History Month 2025 Celebration

Applicant: Holding-Hands (North East) Community Interest Company

Project description: To explore and share African and Caribbean heritage and its evolution in the North East and wider UK through oral history recording, youth-led workshops, culture showcases, discussions and exhibition.

Decision: Award grant of £10,750 (100%)

### Rothbury Estate: for nature and the nation

Applicant: Royal Society of Wildlife Trusts

Project description: To protect and enhance the Rothbury Estate into a key natural and cultural heritage location through stakeholder research and engagement, co-created land management and initiating the creation of a 40-mile nature corridor.

Decision: Award grant of £249,914 (74%)

### Mackem Musical Memories: the history of Sunderland Music City

Applicant: Sunderland Music, Arts and Culture Trust

Project description: To collate Sunderland's music heritage through its participants, producing research and an exhibition to celebrate this in line with the city's recent achievement of International Music City Status.

Project description: To celebrate Leeds Conservatoire's 60th anniversary with a three-year project which will historicise the club's activities in the narrative of Leeds's music history and generate archival material to cement this.

Decision: Award grant of £116,460 (100%)

Project description: To celebrate the school's 40th anniversary by sharing the stories of the diverse community members who made it, by collecting living memories from the community and building them into community events and performances.

Project description: To repair the 900-year-old church building and deliver targeted activities to new audiences, while sharing the building's history and continuing to be a resource for the community.

Decision: Award grant of £245,215 (85%)

Project description: To help South Asian women feel prouder of their heritage through traditional handicraft workshops and promoting practices of reuse and repair.
