National Lottery Heritage Grants £10,000 to £250,000

Change Makers: Addressing the Impacts of Edinburgh's Slavery and Colonial Heritage

Applicant: City of Edinburgh Council

Project Description: This project will aim to progress the delivery of seven of the Edinburgh Slavery and Colonialism Legacy Review Report's recommendations through stakeholder and community engagement, a series of workshops and events, and producing various resources and outputs.
