National Lottery Grants for Heritage schedule of decisions

Girls, Girls, Girls

Applicant: Theatr3

Project Summary: This project looks to record the experiences of past students of a comprehensive school in south Wales and document the building before it is demolished.

Decision: Award a grant of £8,950 (100% of total costs)

Artes Mundi 10: Ein Hiraeth AM10: Perspectives from Home

Applicant: Artes Mundi Prize Limited

Project Summary: A series of co-creative community workshops across Wales examining and placing local heritages within global contexts.

Decision: Award a grant of £99,100 (84% of total costs)

Llangunllo Telephone Box

Applicant: Llangunllo Community Council

Project Summary: Restoring a red telephone box from the reign of King George V situated in Llangunllo in Wales.

Decision: Reject

#DYC Reimagine Nantclwyd y Dre

Applicant: Denbighshire County Council

Project Summary: Help increase knowledge of Nantclwyd y Dre, Wales' second oldest timber framed townhouse, with parts of the house dating back to 1435.

Decision: Award a grant of £9,996 (100% of total costs)

The Great and The Good: Using archaeology to link generations

Applicant: Cambrian Archaeological Association

Project Summary: To record memories and experiences of archaeologists working in Wales during a time of great structural change from the 1960s through to 2000.

Decision: Reject

Menai Strait's Heritage Sailing

Applicant: Menai Strait's Heritage Sailing

Project Summary: A 4-year project, starting in July 2023, to restore a fleet of heritage yachts and create engagement and education resources around the yachts' place in Welsh maritime history.

Decision: Reject

Developing a resilient and sustainable network

Applicant: Wales Environment Link

Project Summary: This two-year project (ending July 2025) aims to increase the resilience and sustainability of Wales's Environment Link (WEL) through a number of organisational development initiatives.

Decision: Award a grant of £116,333 (100% of total costs)

Revealing the Swansea and Surrounding areas' industrial heritage!

Applicant: Congolese Development Project

Project Summary: To investigate the industrial past of Swansea and its district, to locate the various works in time and space using historic maps and photographs, and to identify the traces that remain today.

Decision: Reject

Adopt a Tributary / Mabwysiadu llednant

Applicant: West Wales Rivers Trust

Project Summary: A 13-month project, running from September 2023 to October 2024, that focuses on maintenance and improvement of the river environment in Swansea and Neath Port Talbot.

Decision: Award a grant of £77,255 (100% of total costs)

Dementia Actif Môn

Applicant: Cyngor Sir Ynys Môn - Isle of Anglesey County Council

Project Summary: A project to develop a sensory garden and wildlife habit for the community in the grounds of Plas Arthur Leisure Centre.

Decision: Reject

Menywod a Chwaraeon: Cymru / Women and Sport: Wales

Applicant: Archif Menywod Cymru / Women's Archive of Wales

Project Summary: A two year project, commencing October 2023, aimed at safeguarding the heritage of women's sport in Wales.

Decision: Award a grant of £72,875 (99% of total costs)
