







Expression of Interest guide and questions

How to submit your Expression of Interest form in the Defra Green Recovery Challenge Fund through the online application portal.

If you are not already registered on the portal you will need to register prior to submission.

The Expression of Interest form (EOI) is mandatory for anyone thinking of applying to the Fund for a grant above £250,000. We will use the information you provide in the EOI to decide whether or not to invite you to submit a full application. An invitation to apply does not guarantee a grant from us but does indicate that we see potential in your initial proposals.

We will aim to respond to all EOIs within ten working days of the deadline. If we decide to invite you to apply, you will then have three weeks to submit a full application.

You <u>must</u> read the application guidance before submitting this form. This can be found on our <u>website</u>.

To submit, please complete the form on <u>our application portal</u>. If you decide to copy and paste text directly into your application, please review your application before submission and make changes where necessary to ensure you do not exceed the stated word count limit of 800 words. You will be able to save this document as you work on it.

Please note, the National Lottery Heritage Fund uses a single EOI form for all of the programmes that we administer. Some questions do not need to be answered for the Green Recovery Challenge Fund, so read this guide to understand what information is required where.
