#### **Committee Business**

## 1. Chair's Report

The Chair welcomed Joanne McAleer the new Office Manager, Will Crawford who had started as Grants Officer and Eleanor Potter who was attending her first meeting as Senior Grants Officer.

The Chair said goodbye and thank you to Rory Smith who was leaving Heritage Lottery Fund to start a job at the Homes & Communities Agency, Heather Turvey who had moved to SBD to take up the position of Funding Framework Project Manager and Stuart McLeod, who would be taking a one year sabbatical with the RSA as Head of UK Areas.

The Chair reminded Members that there would be SF5 discussions on the 9 and 10 October and encouraged staff and members to get involved with the forthcoming weekend of Heritage Open Days events.

# 5. Regional Overview

Stuart McLeod presented the paper.

**CSEE 2017 (3) 5** 

The Committee discussed the changes in Places of Worship funding. Staff reported that they had held a strategic stakeholders meeting with Church of England diocese secretaries and a broad representation of churches. The challenge would be supporting smaller churches with the requirements of the open grants programmes. The team were now experiencing a steady stream of applications under the new system and would bring an update to the Committee in November.

# 6. Budget report

Stuart McLeod presented the report.

There were three HG first round cases. The projects total £3,307,800 against a budget of £2,335,600 for the meeting, based on an equal division of the budget between the four meetings whilst allowing for quarterly adjustments in response to demand.

# SF4 first round applications for discussion and decision: Heritage Grants

## 7. Developing the Diving Museum at No2 Battery, Gosport; HG-16-05395

CSEE 2017 (3) 7

Applicant: The Historical Diving Society

Request: First round pass of £1,861,900 including development grant of £149,700 (76% of total eligible development costs)

Project: To conserve and restore a Grade 2\* listed historic gun battery and improve the visitor offer for the UK's only dedicated diving museum. Alongside capital works there would be a range of activities to engage with the local community such as a schools programme, an events programme for children and volunteering opportunities.

The Committee for South East England considered the project a low priority for support and a **REJECTED** it due to the concerns raised.

#### 8. Heritage at the Heart of Graylingwell; HG-16-05889

CSEE 2017 (3) 8

Applicant: Chichester Community Development Trust

Project: To convert Graylingwell Chapel in Chichester into a heritage centre. There would be restoration works to the historic fabric of the building and also additional new structures to create a multi-functional space for the community. The applicant would also tell the stories and experiences of the people who resided and worked at Graylingwell during it's time as a psychiatric hospital through the built heritage and an accompanying activity program.

The Committee for South East England considered the project a HIGH PRIORITY for support and **AWARDED** a first round pass of £1,445,900 including a development grant of £142,900 (68% of total eligible development costs)

# 9. The Lewes Dinosaur; HG-17-01339

Applicant: The Lewes Dinosaur CIC

CSEE 2017 (3) 9

Request: First round pass of £108,600, including a development grant of £8,300 (88& of total eligible development costs)

Project: To commission a public sculpture of a life-sized anatomically correct dinosaur to commemorate Lewes resident Gideon Mantell's early dinosaur discoveries. A range of community engagement activities would be offered alongside the sculpture.

The Committee for South East England **REJECTED** the application due to the concerns raised.

# 13. Watercress and Winterbournes - Hampshire's Chalk River Headwaters Landscape Partnership Scheme; LP-15-08410

Applicant: Hampshire and Isle of Wight Wildlife Trust

Request: First round pass of £2,207,200 including development grant of £269,400 (69% of total eligible development costs)

Project: To enable communities in the catchment to take a central role in caring for their local headwaters, increase the headwaters' water quality and biodiversity, re-establish traditional conservation skills for natural and built heritage and encourage communities to value their heritage environment through deeper understanding.

The Committee for South East England considered the project a **HIGH PRIORTY (1 of 2)** for support

# 14. Upper Thames Landscape Partnership; LP-16-08588

CSEE 2017 (3) 14

Applicant: Berkshire, Buckinghamshire & Oxfordshire Wildlife Trust

Request: First round pass of £2,791,100 (including development grant of £129,800 (86% of total eligible development costs)

Project: Focusing on the floodplain of the Upper Thames region, from Somerford Keynes in Gloucestershire to Oxford city centre, the project would deliver three integrated programmes of works and activities focusing on seven heritage themes. It would involve capital works to waterways and floodplain mosaics, the restoration of significant natural heritage sites and small built heritage features and a series of community engagement activities.

The Committee for South East England considered the project a **MEDIUM PRIORTY** for support.

# 15. Whose Hoo; LP-16-08779

**CSEE 2017 (3) 15** 

Applicant: RSPB South East

Request: First round pass of £1,703,600 including a development grant of £109,400 (69% of total eligible development costs)

Project: To increase the Hoo Peninsula's resilience in the face of current and upcoming challenges to the landscape and heritage. It would restore, reconnect, interpret and celebrate the Peninsula's wildlife habitats, landscape features, buildings and cultural heritage. Alongside these works there would be a range of volunteering, learning and access opportunities for the landscape's inhabitants and visitors.

The Committee for South East England considered the project a **HIGH PRIORITY (2 of 2)** for support

# 17. The Fitted Rigging House [FRH]: Unlocking a sustainable future for the Historic Dockyard Chatham; HE-16-00831

**CSEE 2017 (3) 17** 

Grantee: Chatham Historic Dockyard

Request: Award grant of £4,812,000 (55%)

Project: To transform the Scheduled Ancient Monument and Grade I listed Fitted Rigging House from its current deteriorating condition into a multi-use asset in keeping with the building's heritage significance. The project would repair and fit out two floors of this underused building to deliver a range of new uses to develop new income streams to help ensure a sustainable future for CHDT.

Uplift: N/A

The Board had awarded a first round pass of £4,823,000 including a development grant of £11,000 (5% of eligible development costs) in November 2016.

The Committee for South East recommended the project as a **HIGH PRIORITY** for support.

# 18. Beacons of the Past (cross territory)

**CSEE 2017 (3) 18** 

Grantee: Chilterns Conservation Board

Request: Award Grant of £695,600 (78%)

Project: a cross-territory project to survey, conserve and interpret the Chilterns Iron Age hillforts. Work would include a large scale LiDAR survey of the Chilterns in the South East and East of England to reveal features in densely wooded areas, undertake conservation works at selected sites and provide both physical and digital interpretation.

Uplift: N/A

The Board had awarded a first round pass of £745,800 including a development grant of £50,200 (73% of total eligible development costs) in January 2016

The Committee for South East recommended the project as a **HIGH PRIORITY** for support.
