A performance piece will be written based on the findings along with a website and exhibition. The applicant will research everyday experiences, pay, conditions and the impact on family lives. 2	Solihull and the Great War – Children's Remembrance Project	This 12 month project will engage with 50 primary school children to explore Solihull's heritage relating to the First World War. 3	Restoration, Relocation and Public Awareness of Langley's Memorial Window for the First World War	The project will restore a memorial window, removed recently from one church following its sale, and install it in another local church. The window was paid for in 1921 by public subscription, and is the First World War Memorial for Langley. 5	Reaching out Arms – The Story of WW1 on Cannock Chase Phase 1	The project focuses on FWW military and home front stories of Cannock Chase AONB during. The Chase hosted around 40,000 British and Commonwealth soldiers in two training camps (Rugeley and Brocton Camp) where they received training before leaving for the Western Front. 6	Hospital Walking History	The project aims to develop and run volunteer led walking tours within the upper corridors of the recently built Queen Elisabeth Hospital, offering panoramic views of the Birmingham area, taking in key social and industrial heritage sites of the 19th and 20th centuries such as: The longbridge site (former Austin and Rover group factories), Lickey Hills (gifted from the Cadbury family to the people of Birmingham), Cadbury factory and Bournville village and the University of Birmingham (related to Joseph Chamberlain).
