2.	The Kingston Crocodile	During the first world war, women from Kingston Upon Thames were drafted into the local Sopwith Aircraft Factory to make planes. It's suspected that some started manufacturing toys from the offcuts of wood used on the planes. This project will explore this idea using local history rooms' collection to discover the identities of the women who worked in the factory.
